#### Directions for Use:

##### In-Furrow Application

- Applicator should be calibrated to achieve recommended rate. Shake bladder well before opening. Settling of bacteria is normal; shaking the product will achieve uniform distribution of the bacteria. Pour entire contents of bladder and bottle of biostimulant into a clean liquid delivery system tank. Add cool, clean, non-chlorinated water to the appropriate level. Use a minimum of 5-10 gallons of water per acre to dilute the product properly. Mild agitation is recommended to obtain an even water/inoculant/biostimulant mixture. Do not mix more EXCEED<sup>SAR</sup> LIQUID FOR PEANUTS than can be used in one day. Do not allow the tank mix to exceed 80°F.
- Apply EXCEED<sup>SAR</sup> LIQUID FOR PEANUTS in-furrow at a rate of 1.1 fl. oz. per 1000 ft. of row or 35 fl. oz per 1000 ft of row in dilution. One 1.1 gal. container at the 1.1 fl. oz. rate will treat 10 acres in-furrow on 36" row spacing.
- Apply to the seed trench, do not apply banded to the side, below, or above the seed. Plant into moist soils. In hot, dry soils, irrigate ground starting with the seed that was planted first as soon as possible. Extended periods of hot, dry soils may have a detrimental effect on the viability of the rhizobium. EXCEED<sup>SAR</sup> LIQUID FOR PEANUTS should only be applied in-furrow and should never be seed applied.
